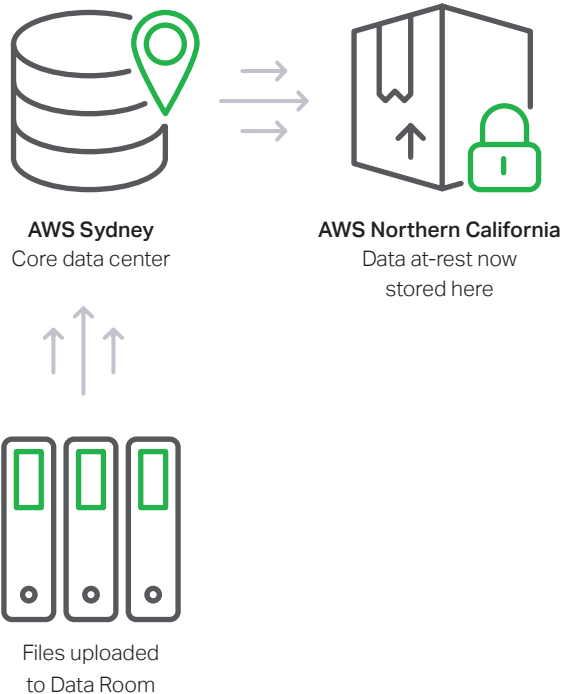
# Data and privacy requirements are a growing concern

New laws – particularly those that guide and protect how our data is used – are being developed quickly to keep pace with changing technologies. Changes in legislation can vary widely from region to region, as seen with the [EU specific GDPR](#).

## Introducing Global Document Storage

To help our global customer base navigate their own regional requirements, we now have localized document storage in Europe, South-East Asia, and the United States for our Data Rooms, as well as at our base in Australia.

This gives our customers flexibility and peace of mind, without compromising the security of our Data Rooms. It means complete confidence you’re complying with regional legislation, with the power of our global team behind you. We’ll stay up to date with the rapidly changing requirements, so you don’t have to.



## So how does it work?

Our core data centers remain at our headquarters in Australia, providing power and stability to our product, while all at-rest content can be stored in-region by our customers based on their requirements. This ensures the product retains effectiveness, while giving customers the benefit of choice.

During the setup of your Data Room, you can choose the document storage location that will keep you compliant with the requirements of your region.

All our data is hosted on the [Amazon Web Services \(AWS\) platform](#) whose infrastructure guarantees the highest level of data security.

## FAQs

### Q. Which regions will be available to store documents?

You will be able to store your at-rest documents at locations within Europe, South-East Asia, the United States and Australia. It's important to note that documents are initially processed through our headquarters in Sydney where our largest data center is housed, before they are able to be securely transferred to the regional hub of your choice.

### Q. What is the default location?

The default location is Sydney, Australia, where our headquarters are based. Unless you specify a preferred location for your documents to be stored, they will automatically be assigned to the default.

### Q. Can I change my location after setting up my Data Room?

No, once the decision is made at Data Room creation, the location cannot be changed. Having the choice of where your documents are stored applies to any new Data Room created, but cannot be amended for existing Data Rooms that have already been set up.

### Q. Is localized document storage available for the Material Information Platform?

At this stage, localized document storage is available just for our Data Room product.

An AWS region is defined as a geographically separated and distinct data centre, which is how AWS provides the opportunity for us to store your data in the geographic area of your choice.

## Better data security through guaranteed infrastructure

- Only Ansarada has access to data stored on AWS
- All data is stored encrypted in either AWS S3 (Simple Storage Service) or AWS EBS (Elastic Block Storage)
- All data uploaded into the Data Room is done over HTTPS/SSL and then encrypted by Ansarada for storage
- All internal communication of data between services also occurs over HTTPS/SSL
- No reliance on any security technologies made available by AWS, but they are used as a secondary layer of security
- Ansarada still manage all encryption and data transfer security
- Guaranteed availability to shared resources i.e. ensuring complete data segregation
- Virtual elimination of risks from Trojans, Worms, Viruses and Application Vulnerabilities
- Improved ability to access data, if a region becomes unavailable
